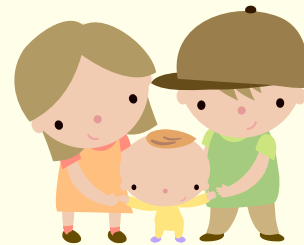

- 家庭是社會的基石

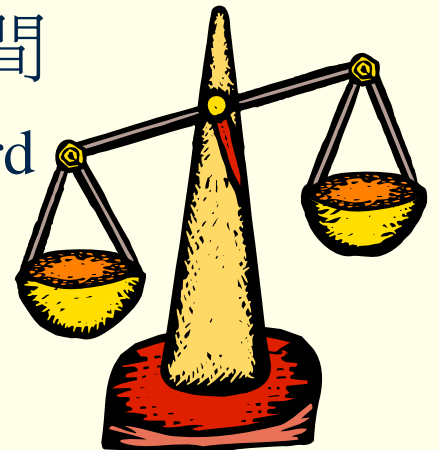
Family is the basic unit of a society.

Balance: Intrusion of family affairs **Vs** Safeguard personal social space

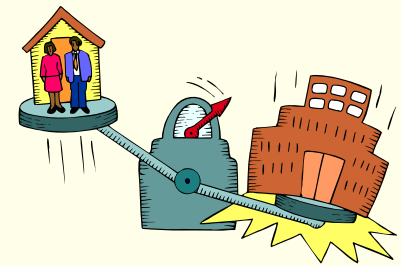
家庭遇到的主要挑戰

Domestic violence cases on the rise
